Fuller's LLC suggests that the bidder submits absentee bids if the bidder is unsure of their whereabouts at the time of the sale. All requests for overseas telephone lines must be accompanied by absentee bids that will be executed on the bidder's behalf in the event of any problems with the telephone connection.
